This Texas Securities Board adopted Rule 147 on Nov-2014. Our CEO/ Founder is among the most knowledgeable executives in the space. The Bill we work from: The 85th Texas Legislature just adopted House Bill 1629. "The Board shall adopt rules to regulate and facilitate online intrastate crowdfunding applicable to authorized small business development entities. The Board may create other requirements necessary to carry out this section." Our service will be mandated by the local Citys' Mayors. At the current time, we are the only ancillary service provider in the State that offers the complete process from set up to funding. WE consult and set up Texas Intrastate Crowdfunding Portals (TCPs) for Texas' EDCs, there are over 700 EDCs in the State. This HB 1629 allows EDCs to facilitate Mini IPOs for Texas businesses (Issuers) through State Approved Crowdfunding Portals (TCPs). These TCPs then charge between 7-10% to facilitate these offers. A typical fee received from a max cap offer of \$1M @ 7% will net an EDC \$70,000.00 // 10 Per Year \$700,000.00. As an ancillary service provider we are able to offer ALL of the necessary services to complete the IPO for the issuer by; We assist in finding the businesses needing to raise capital, creating the documents/structure of the offer, we also promote the offer to the Texas Investors through social media (An investor needs to be a Texas Resident, the age of 18 or over, he/she may invest up to \$5000.00 per year and the Issuer/Business which may raise up to \$1 M over a 12 month period.
